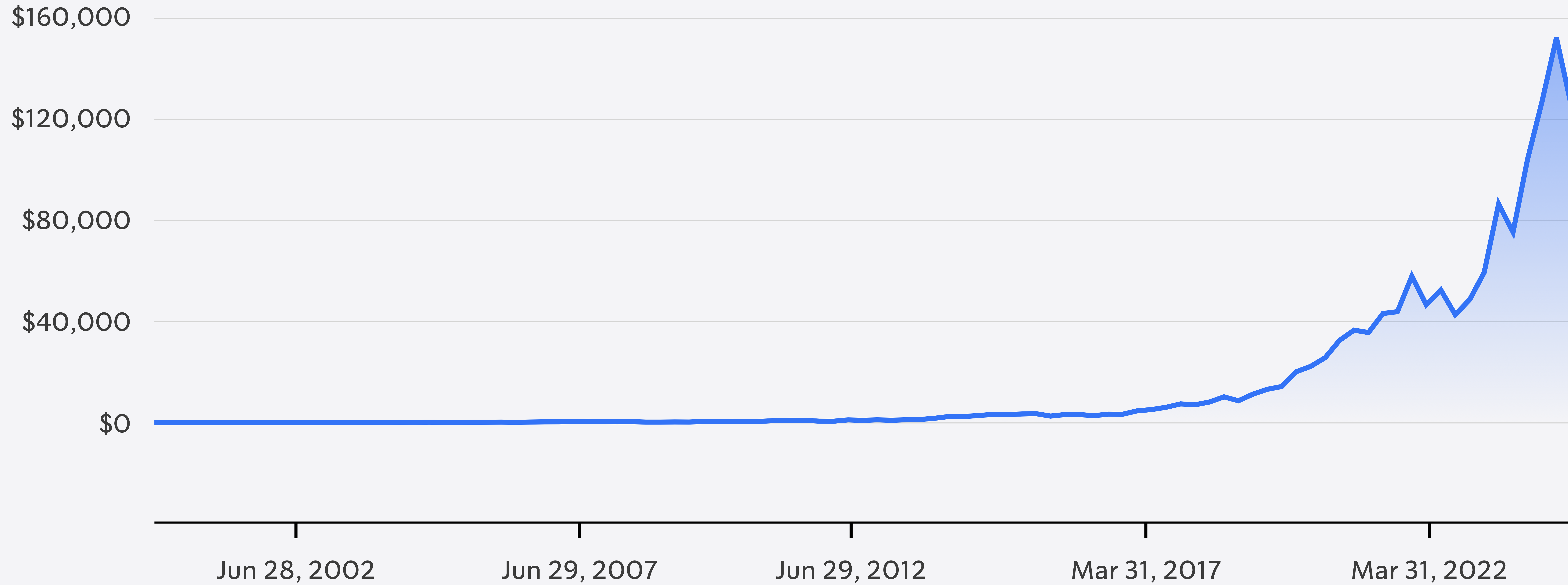

Fund X Strategy Backtest: Quarterly Drawdown From Peak

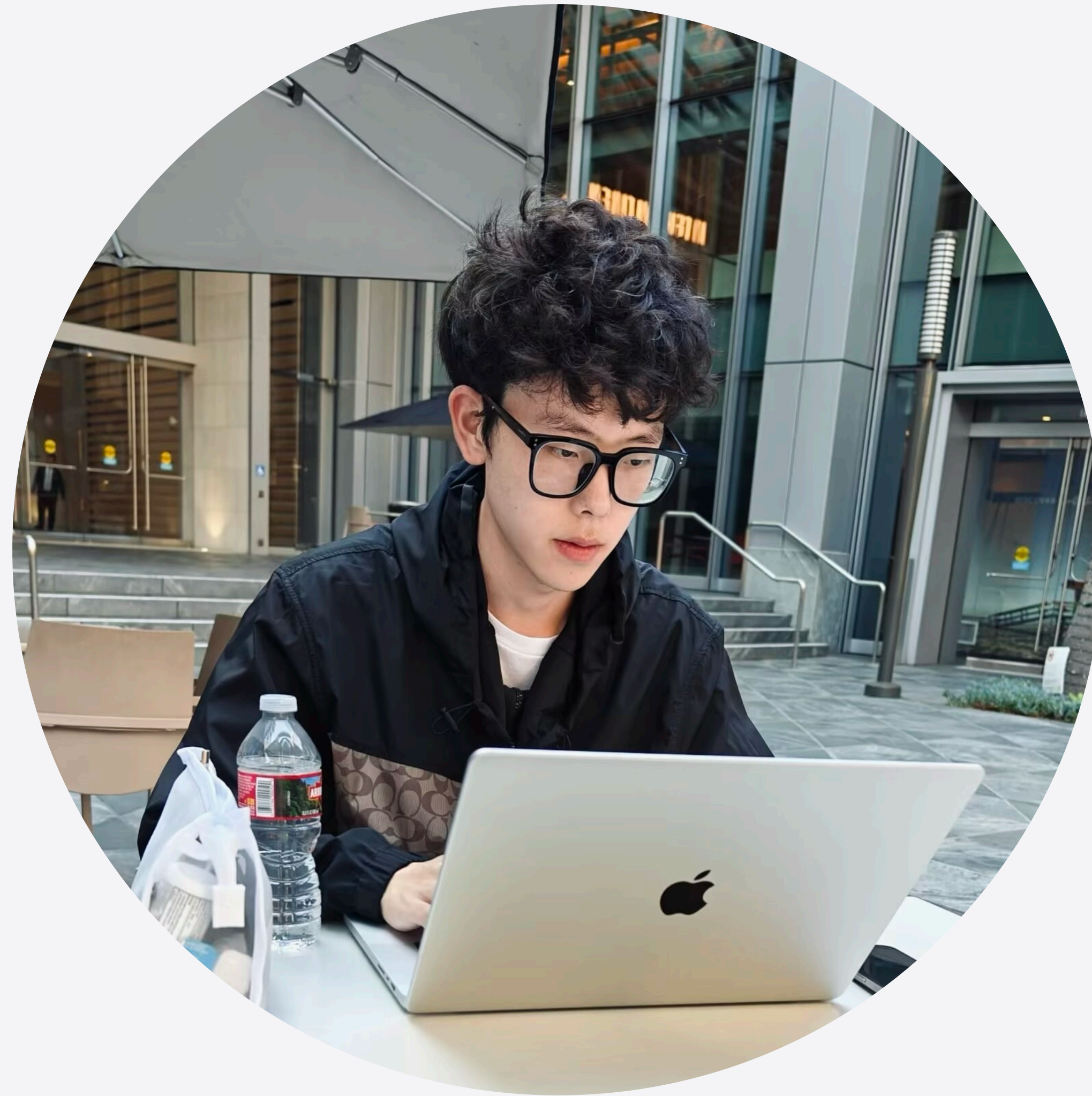

“In Q3 2024, we made the strategic decision to shift from monthly to quarterly performance reports. This change is aimed at encouraging both investors and fund managers to adopt a longer-term perspective on investments. Investing is a marathon that requires patience and endurance. By moving to a quarterly format, we hope to focus on sustainable, long-term growth.

During this quarter, **Fund X** experienced a significant drawdown, though it remained within the expected range based on backtesting data. We remain confident in the resilience of Fund X’s strategy and its potential for substantial growth in the future. High risks often come with high returns, and we urge investors not to lose confidence in the market due to short-term volatility.

On the strategy front, we reduced the overall leverage of the fund, exiting some high-risk leveraged positions to mitigate the impact of potential drawdowns. In addition, we made optimizations to our **Stargate System**, which we believe will contribute meaningfully to the fund’s performance in the coming periods.”
